**SUBJECT**

(ALL) Adopt Ordinance Amending Chapter 22 Motor Vehicles and Traffic, Article III Operation of Vehicles, Section 22-86 Speeding, Subsection (h) of the Code of the City of Fort Worth, Texas (2015), as Amended, to Change the Locations, Extent, and Speed Limits of Certain School Zones and Add the Speed Limits of Certain Speed Zones

**RECOMMENDATION:**

It is recommended that the City Council adopt the attached ordinance amending Chapter 22 Motor Vehicles and Traffic, Article III Operation of Vehicles, Section 22-86 Speeding Subsections (h) of the Code of the City of Fort Worth, Texas (2015), as amended, to change the locations, extent, and speed limits of certain school zones and add the speed limits of certain speed zones.

**DISCUSSION:**

The purpose of this Mayor and Council Communication (M&C) is to add new school zones, modify existing school zones, and install new speed limit signs. Chapter 22 Motor Vehicles and Traffic, Article III Operation of Vehicles, Section 22-86 Speeding, Subsections (h) of the Code of the City of Fort Worth, Texas (2015), includes school zone tables for various streets throughout the City. The City's Transportation and Public Works (TPW) Department routinely reviews the speed limits in the City Code in order to make corrections, additions, or amendments where appropriate. The City's TPW Department desires to amend the school zones tables included in the City Code to provide for adjustments as a result of development and to make text, speed limit, and block range corrections. Section 545.356 of the Texas Transportation Code specifies the procedures for establishing school zones and posted speed limits. The attached ordinance changes are based upon completed engineering and traffic investigations. The City's TPW Department recommends amending Section 22-86, Subsections (h) of the City Code to provide for adjustments as a result of recently completed City roadway projects and traffic studies. This ordinance will establish school zone limits for the following locations (See Exhibit 1):
