(ALL) Authorize Execution of Non-Exclusive Purchase Agreements with DPC Industries Inc., HD Supply Facilities Maintenance, Ltd. dba USABluebook, DPC Industries Limited Partnership, Brenntag Southwest Inc., Texas Lime Company, Pennco Inc., Lhoist North America of Texas LLC, Chemtrade Chemicals US LLC, Univar Solutions USA Inc., Linde Inc., G2O Technologies LLC, Polydyne Inc., and Ineos Calabrian Corporation for Water Treatment Chemicals for the Water Department in a Combined Annual Amount Up to \$23,493,906.80 for the Initial Term and Authorize Four, One-Year Renewals for the Same Annual Amount

RECOMMENDATION:

It is recommended that the City Council authorize execution of non-exclusive purchase agreements with DPC Industries Inc., HD Supply Facilities Maintenance, Ltd. dba USABluebook, DPC Industries Limited Partnership, Brenntag Southwest Inc., Texas Lime Company, Pennco Inc., Lhoist North America of Texas LLC, Chemtrade Chemicals US LLC, Univar Solutions USA Inc., Linde Inc., G2O Technologies LLC, Polydyne Inc., and Ineos Calabrian Corporation for water treatment chemicals for the Water Department in a combined annual amount up to \$23,493,906.80 for the initial term and authorize four, one-year renewals for the same annual amount.

DISCUSSION:

The Water Department approached the Purchasing Division for assistance with securing an agreement for bulk water treatment chemicals to treat drinking water, wastewater, and industrial waste at various water treatment plants throughout the City of Fort Worth. Purchasing issued an Invitation to Bid (ITB) that consisted of detailed specifications regarding the requirements for the water treatment chemicals, delivery and certification requirements meeting American Water Works Association (AWWA), American National Standards Institute (ANSI), and National Sanitation Foundation (NSF) specifications. The ITB was advertised in the *Fort Worth Star-Telegram* on March 16, 2022, March 23, 2022, March 30, 2022, and April 6, 2022. The City received 15 responses. Chameleon Industries, Inc. was deemed non-responsive due to not submitting all required bid documentation.

Staff evaluated the remaining bid responses on lowest, responsible bidder criteria and recommends awarding a one-year, non-exclusive purchase agreement to DPC Industries Inc., HD Supply Facilities Maintenance, Ltd. dba USABluebook, DPC Industries Limited Partnership, Brenntag Southwest Inc., Texas Lime Company, Pennco Inc., Lhoist North America of Texas LLC, Chemtrade Chemicals US LLC, Univar Solutions USA Inc., Linde Inc., G2O Technologies LLC, Polydyne Inc., and Ineos Calabrian Corporation with four, additional one-year renewals per the line items listed below. No guarantee was made that all amounts of these items will be purchased.

ADMINISTRATIVE CHANGE ORDER: An administrative change order or increase may be made by the City Manager up to the amount allowed by relevant law and the Fort Worth City Code and does not require specific City Council approval as long as sufficient funds have been appropriated.

Funding is budgeted in the Water Department's rollup within the Water & Sewer Fund.

AGREEMENT TERMS: Upon City Council approval, this agreement shall begin upon execution and expire one year from that date.

RENEWAL TERMS: This agreement may be renewed for four additional, one-year terms. This action does not require specific City Council approval provided that the City Council has appropriated sufficient funds to satisfy the City's obligations during the renewal term.

DVIN-BE: A waiver of the goal for Business Equity subcontracting requirement is approved by the DVIN-BE, in accordance with the Business Equity Ordinance, because the purchase of goods or services is from sources where subcontracting or supplier opportunities are negligible.

FISCAL INFORMATION / CERTIFICATION:

The Director of Finance certifies that funds are available in the current operating budget, as previously appropriated, in the Water and Sewer Fund to support the approval of the above recommendation and award of the agreement. Prior to any expenditure being incurred, the Water Department has the responsibility to validate the availability of fund.
