LEGAL DESCRIPTION

RIGHT-OF-WAY ABANDONMENT

BEING a 1.2148 acre (52,919 square foot) tract of land situated in the Isaac Thomas Survey, Abstract No. 1526 and the Edmund Little Survey, Abstract No. 954, City of Fort Worth, Tarrant County, Texas; said tract being part of Niles City Boulevard, a 52-foot wide right-of-way, described in Street and Utility Easement recorded in Volume 6997, Page 1980, Deed Records, Tarrant County, Texas; said tract being more particularly described as follows:

COMMENCING at a 1/2-inch iron rod found at the intersection of the north right-of-way line of NE 23rd Street (a variable width right-of-way) and the east right-of-way line of Packers Avenue (a variable width right-of-way);

THENCE North 89°45'44" East, along the said north right-of-way line of NE 23rd Street, a distance of 145.82 feet to a 1/2-inch iron rod found for the **POINT OF BEGINNING** at the intersection of the said north right-of-way line of N. 23rd Street and the west right-of-way line of said Niles City Boulevard;

THENCE along the said west right-of-way line of Niles City Boulevard the following four (4) calls;

North 0°12'17" West, a distance of 290.51 feet to a 1/2-inch iron rod found at the beginning of a non-tangent curve to the right having a central angle of 16°56'49", a radius of 739.81 feet, a chord bearing and distance of North 8°17'16" East, 218.02 feet;

In a northeasterly direction, with said curve to the right, an arc distance of 218.82 feet to a 1/2-inch iron rod found at the beginning of a non-tangent curve to the left having a central angle of 41°19'38", a radius of 684.00 feet, a chord bearing and distance of North 3°51'25" West, 482.74 feet;

In a northwesterly direction, with said curve to the left, an arc distance of 493.37 feet to a point for corner;

North 24°18'57" West, a distance of 13.79 feet to a point for corner in the south right-of-way line of Exchange Avenue (a variable width right-of-way);

THENCE South 89°58'54" East, along the said south right-of-way line of Exchange Avenue, a distance of 61.53 feet to a 5/8-inch iron rod set at the intersection of the said south right-of-way line of Exchange Avenue and the east right-of-way line of said Niles City Boulevard; said point being at the beginning of a non-tangent curve to the right having a central angle of 0°21'14", a radius of 740.00 feet, a chord bearing and distance of South 23°24'49" East, 4.57 feet;

THENCE along the said east right-of-way line of Niles City Boulevard the following six (6) calls;

In a southeasterly direction, with said curve to the right, an arc distance of 4.57 feet to a point for corner;

South 0°06'06" East, a distance of 10.34 feet to a point at the beginning of a non-tangent curve to the right having a central angle of 39°16'48", a radius of 736.00 feet, a chord bearing and distance of South 2°51'24" East, 494.75 feet;

In a southeasterly direction, with said curve to the right, an arc distance of 504.57 feet to a 1/2-inch iron rod found at the beginning of a non-tangent curve to the left having a central angle of 17°01'06", a radius of 687.81 feet, a chord bearing and distance of South 8°12'43" West, 203.55 feet;

In a southwesterly direction, with said curve to the left, an arc distance of 204.30 feet to a point for corner;

South 0°09'33" East, a distance of 290.25 feet to a point for corner at the intersection of the said east right-of-way line of Niles City Boulevard and the north right-of-way line of NE 23rd Street;

THENCE South 89°55'43" West, along the said north right-of-way line of NE 23rd Street, a distance of 52.00 feet to the POINT OF BEGINNING and containing 1.2148 acres or 52,919 square feet of land, more or less.
