RECOMMENDATION:

It is recommended that the City Council adopt the attached resolution authorizing execution of an advance funding agreement (CSJ# 0094-05-071) with the Texas Department of Transportation in the amount of \$726,279.00 of which \$173,801.00 is City participation for the State Highway 183 at Green Oaks Road Highway Safety Improvement project (City Project No. 103640).

DISCUSSION:

The purpose of this Mayor and Council Communication (M&C) is to adopt a resolution authorizing execution of an Advance Funding Agreement (AFA) with the Texas Department of Transportation (TXDOT) in the amount of \$726,279.00 of which \$173,801.00 is City participation for the State Highway 183 at Green Oaks Road Highway Safety Improvement project (City Project No. 103640).

The scope of this project includes signal rebuild, American with Disabilities Act (ADA) ramps, safety lighting, flashing yellow arrow for northbound and southbound movements, new crosswalks and pavement markings, signal advance warning sign for westbound approach and improve northbound/southbound left turn offset.

This project will be let by TXDOT in June 2023. The State will be responsible for securing the federal and State share of the funding required for the development and construction of the project. City funds have been appropriated to this project for design, right-of-way utilities and project management purposes. The City bears the responsibility to pay for cost overruns.

This project is included in the 2018 Bond Program. Available resources within the General Fund will be used to provide interim financing until debt is issued. Once debt associated with the project is sold, bond proceeds will reimburse the General Fund in accordance with the statement expressing official Intent to Reimburse that was adopted as part of the ordinance canvassing the bond election (Ordinance No. 23209-05-2018) and subsequent actions taken by the Mayor and Council.

Funding for the required City participation would be from the 2014 & 2018 Bond Programs of which a portion of this funding was appropriated to the project in a separate M&C.
