(CD 4) Adopt Resolution Authorizing Execution of an Advance Funding Agreement with the Texas Department of Transportation in the Amount of \$475,470.00, of Which \$170,667.00 is City Participation for the State Highway 183 at North Beach Street Highway Safety Improvement Project (2018 Bond Program)

RECOMMENDATION:

It is recommended that the City Council adopt the attached resolution authorizing execution of an advance funding agreement (CSJ# 0094-01-041) with the Texas Department of Transportation in the amount of \$475,470.00, of which \$170,667.00 is City participation for the State Highway 183 at North Beach Street Highway Safety Improvement project (City Project No. 103642).

DISCUSSION:

The purpose of this Mayor and Council Communication (M&C) is to adopt a resolution authorizing execution of an Advance Funding Agreement (AFA) with the Texas Department of Transportation (TXDOT) in the amount of \$475,470.00, of which federal participation is in the amount of \$229,787.00, state participation is in the amount of \$75,016.00 and \$170,667.00 is City participation for the State Highway 183 at North Beach Street Highway Safety Improvement project (City Project No. 103642).

The scope of this project includes signal rebuild including signal improvements including Audible Pedestrian System (APS), refresh pavement markings, flashing yellow arrow for all approaches, new raised median, and advance signal warning signs for all approaches signal improvements.

This project will be led by TXDOT in June 2023. The State will be responsible for securing the federal and State share of the funding required for the development and construction of the project. City funds have been appropriated to this project for design, right-of-way, utilities and project management purposes. The City bears the responsibility to pay for cost overruns.

This project is included in the 2018 Bond Program. Available resources within the General Fund will be used to provide interim financing until debt is issued. Once debt associated with the project is sold, bond proceeds will reimburse the General Fund in accordance with the statement expressing official Intent to Reimburse that was adopted as part of the ordinance canvassing the bond election (Ordinance No. 23209-05-2018) and subsequent actions taken by the Mayor and Council.

Funding for the required City participation is budgeted in the 2018 Bond Program Fund for the purpose of funding the State Highway 183 at North Beach project, as appropriated.

This project is located in COUNCIL DISTRICT 4.
