AN ORDINANCE ADJUSTING ESTIMATED RECEIPTS AND APPROPRIATIONS AMONG IDENTIFIED PROJECTS IN THE 2022 BOND PROGRAM FUND, WITH THE TOTAL OF SUCH ADJUSTMENTS BEING \$24,955,731.00 BUT WITH NO NET CHANGE TO TOTAL APPROPRIATIONS IN THE FUND; PROVIDING FOR A SEVERABILITY CLAUSE; MAKING THIS ORDINANCE CUMULATIVE OF PRIOR ORDINANCES; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS:

SECTION 1.

That the budget of the City of Fort Worth for Fiscal Year 2022-2023, as enacted by Ordinance 25773-09-2022, as amended, is hereby further amended to make adjustments, as indicated below, to identified projects in the 2022 Bond Program Fund with the total of all such adjustments being \$24,955,731.00, but with no net change to the total appropriations within the Fund:
