RECOMMENDATION:

It is recommended that the City Council authorize execution of a contract with Peachtree Construction, Ltd., in the amount of \$2,005,975.00 for the rehabilitation of various streets as part of 2023 Asphalt Resurfacing Contract 1 (City Project No. 104269).

DISCUSSION:

In the Fiscal Year 2023 Pay-Go Contract Street Maintenance Program, groups various types of street maintenance into specific contract packages. The recommended construction contract proposed in this Mayor and Council Communication (M&C) will provide street rehabilitation for the street sections listed below as part of 2023 Asphalt Resurfacing Contract 1 project (City Project No. 104269).

Construction on these street segments is expected to start in late 2022 and to be completed by summer 2023. There will be no anticipated impact on the General Fund operating budget upon completion of this contract.

This project was advertised for bid on August 11, 2022, and August 18, 2022, in the *Fort Worth Star-Telegram*. On September 8, 2022, the following bids were received:

M/WBE OFFICE– Peachtree Construction, Ltd. is in compliance with the City's Business Equity Ordinance by committing to 22% MBE participation on this project. The City's MWBE goal on this project is 20%.

This project is located in COUNCIL DISTRICT 3 & 9.

FISCAL INFORMATION / CERTIFICATION:

The Director of Finance certifies that funds are available in the current capital budget, as previously appropriated, in the General Capital Projects Fund for 2023 Asphalt Resurf Contract 1 to support the approval of the above recommendation and execution of the contract.
