## SUBJECT

## **RECOMMENDATION:**

It is recommended that the City Council authorize the execution of a contract with Urban Infraconstruction, LLC, in the amount of \$1,627,186.00 for 2023 Concrete Restoration Contract 3 project (City Project No. 104182) at various locations.

#### **DISCUSSION:**

In the Fiscal Year 2023 Pay-Go Contract Street Maintenance Program, various types of street maintenance are grouped into specific contract packages. The 2023 Concrete Restoration Contract 3 provides for the repair and reconstruction of failed concrete pavement at three locations listed below under the Contract Street Maintenance Program (City Project No. 104182).

Construction for this project is expected to start in winter 2022 and be completed by summer 2023. Upon completion of the project there will be no anticipated impact on the General Fund operating budget.

This project was advertised for bid on July 28, 2022 and August 4, 2022 in the *Fort Worth Star-Telegram*. On August 25, 2022, the following bids were received:

Funding is budgeted in the TPW Highway & Streets Department's General Capital Projects Fund for the purpose of funding the 2023 Concrete Restoration Contract 3 project, as appropriated.

M/WBE OFFICE – Urban Infraconstruction, LLC is in compliance with the City's Business Equity Ordinance by committing to 60% MWBE participation on this project. The City's MWBE goal on this project is 21%.

This project is located in COUNCIL DISTRICTS 2, 4, 7 and 9.

#### FISCAL INFORMATION / CERTIFICATION:

The Director of Finance certifies that funds are available in the current capital budget, as previously appropriated, in the General Capital Projects Fund for the 2023 Concrete Res Contract 3 to support the approval of the above recommendation and award of the contract. Prior to any expenditure being incurred, the Transportation and Public Works Department has the responsibility to validate the availability of funds.
