AN ORDINANCE ADJUSTING ESTIMATED RECEIPTS AND APPROPRIATIONS IN THE INTERGOVERNMENTAL CONTRIBUTION FUND, FROM TARRANT COUNTY IN THE COLLECTIVE AMOUNT OF \$78,410,000, FOR THE PURPOSE OF PROVIDING FUNDING AMONGST SEVERAL PROJECTS; PROVIDING FOR A SEVERABILITY CLAUSE; MAKING THIS ORDINANCE CUMULATIVE OF PRIOR ORDINANCES; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS:

## SECTION 1.

That in addition to those amounts allocated to the various City departments for Fiscal Year 2022-2023 in the Budget of the City Manager, there shall also be an adjustment of estimated receipts and appropriations in the Intergovernmental Contribution Fund, from Tarrant County contributions, for the purpose of providing funding amongst the following projects:
