AN ORDINANCE ADJUSTING ESTIMATED RECEIPTS AND APPROPRIATIONS IN THE STORMWATER REVENUE BONDS 2020 FUND BY INCREASING ESTIMATED RECEIPTS AND APPROPRIATIONS IN CERTAIN IDENTIFIED PROJECTS (CITY PROJECT NOS. 103664, 103665) IN THE AMOUNT OF \$4,897,089.35 AND DECREASING ESTIMATED RECEIPTS AND APPROPRIATIONS IN OTHER IDENTIFIED PROJECTS (CITY PROJECT NOS. 103051, C01669, 103058, 103053, 104018, P00120, 103887, P00136) BY THE SAME AMOUNT; PROVIDING FOR A SEVERABILITY CLAUSE; MAKING THIS ORDINANCE CUMULATIVE OF PRIOR ORDINANCES; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH: AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS:

SECTION 1.

That in addition to those amounts allocated to the various City departments for Fiscal Year 2022-2023 in the Budget of the City Manager, there shall also be an adjustment of estimated receipts and appropriations in the Stormwater Revenue Bonds 2020 by increasing estimated receipts and appropriations in certain identified projects (City Project Nos. 103664, 103665) Fund in the amount of \$4,897,089.35 and decreasing estimated receipts and appropriations in other identified projects (City Project Nos. 103051, C01669, 103058, 103053, 104018, P00120, 103887, P00136) by the same amount:
