(CD 4 and CD 5 / Future CD 2 and CD 5) Authorize Execution of a Contract with Straight Line Sawing & Sealing, Inc., in the Amount of \$484,000.00 for the 2023 Joint Seal Contract Project

RECOMMENDATION:

It is recommended that the City Council authorize execution of a contract with Straight Line Sawing & Sealing, Inc., in the amount of \$484,000.00 for the cleaning and filling of concrete pavement joints and the repair of concrete at various locations as part of the 2023 Joint Seal Contract and provide for two renewals (City Project No. 104618).

DISCUSSION:

The Fiscal Year 2023 Pay-Go Contract Street Maintenance Program groups various types of street maintenance into specific contract packages. The 2023 Joint Seal Contract project provides the cleaning and filling of concrete pavement joints with silicone sealant, along with the repair of concrete spalling on select pavement panels at various street sections on Cooks Lane and North Sylvania Avenue. The specific locations are listed below:

Construction for this project is expected to start in Summer 2023 and to be completed by Fall 2023. There is no anticipated impact on the General Fund operating budget upon completion of this project.

This contract may be renewed up to two additional terms at the expiration of contract funds or time, whichever occurs first, under the same terms, conditions, and unit prices.

This project was advertised for bid on March 2, 2023 and March 9, 2023, in the Fort Worth Star-Telegram. On March 30, 2023, the following bids were received:

M/WBE OFFICE – Straight Line Sawing & Sealing, Inc. is in compliance with the City's BDE Ordinance by committing to 85% MWBE participation on this project. The City's MWBE goal on this project is 8%. Additionally, Straight Line Sawing & Sealing, Inc. is a certified M/WBE Firm.

Funding is budgeted in TPW Dept Highway & Streets Department's General Capital Projects Fund for the purpose of funding the 2023 Joint Seal Contract project, as appropriated.

This project is located in current COUNCIL DISTRICTS 4 & 5 and future COUNCIL DISTRICTS 2 & 5.
