RECOMMENDATION:

It is recommended that the City Council authorize execution of a contract with Gibson & Associates, Inc., in the amount of \$942,626.10 for the 2023 Bridge Rehabilitation Contract 1 project (City Project No. 104687) at seventeen locations.

DISCUSSION:

The purpose of the Mayor and Council Communication (M&C) is to authorize the execution of a contract with Gibson & Associates, Inc., in the amount of \$942,626.10 for 2023 Bridge Rehabilitation Contract 1 project at multiple locations. The contract provides for the repair and rehabilitation of seventeen bridges listed below:

Major bridge repair and rehabilitation includes vertical and overhead concrete structural repair; concrete beam repair; metal toe rail installation; bridge approach slab replacement; expansion joint replacement; metal beam guard fence repair, and guardrail end treatment replacement. Construction is expected to start in summer 2023 and be completed by winter 2023. Upon completion of the project, there will be no anticipated impact on the general fund operating budget. The project was advertised for bid on February 23, 2023 and March 2, 2023 in the *Fort Worth Star-Telegram*. On March 30, 2023, the following bids were received:
