A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS, ADDING CITY COUNCIL WORK SESSIONS FOR BUDGET RELATED PRESENTATIONS AND DISCUSSIONS AND ADDING A CITY COUNCIL MEETING TO HANDLE CERTAIN BUDGET RELATED ITEMS

WHEREAS, Part I, Chapter III, Section 5 of the City Charter states that the City Council shall meet at such times and places as may be prescribed by Ordinance or Resolution;

WHEREAS, Section 3.2 of the City Council Rules of Procedure states that unless otherwise officially changed by the City Council, the City Council shall meet in the City Council Conference Room and Council Chamber respectively at Fort Worth City Hall ("City Hall") on Tuesday of each week at times set by the City Council by Resolution in order to be briefed on matters of interest to the city and conduct other city business; and

WHEREAS, adoption of this Resolution serves as official action by the City Council in accordance with the City Charter and City Council Rules of Procedure setting City Council Work Sessions and a City Council Meeting for certain budget related items.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS, THAT:

1. The City Council will hold City Council Work Sessions on the Budget during April, May, June, August, and September 2024 as follows:

- a. April 30, 2024;
- b. May 7, 2024;
- c. June 4, 2024;
- d. August 22, 2024;
- e. August 23, 2024;
- f. September 5, 2024; and
- g. September 6, 2024.

These Work Sessions are anticipated to start at 10:00 a.m. but may start at such other time as reflected in the posted agenda for such meeting, which agenda shall be published in advance in accordance with state law.

2. The City Council will hold a City Council Meeting on September 10, 2024 to hold a public hearing on the budget and potentially address other budget related items. This City Council Meeting is anticipated to start at 10:00 a.m. but may start at such other time as reflected in the posted agenda for such meeting, which agenda shall be published in advance in accordance with state law.

3. A calendar indicating the above dates is attached to this Resolution as Exhibit A.

4. It is anticipated that the City Council Work Sessions and City Council Meeting referred to in this Resolution will be held at City Hall but may be held at such other location as reflected in the posted agenda for such meeting, which agenda shall be published in advance in accordance with state law.
