#### **SUBJECT**

Authorize Execution of an Engineering Agreement with CP&Y, Inc. in the Amount of \$277,159.00 for Sanitary Sewer Rehabilitation, Contract 102 Project in the Bluebonnet Hills, Westcliff West, Westcliff, Colonial Hills and Como Neighborhood Areas and Adopt Appropriation Ordinance (COUNCIL DISTRICTS 3, 5 and 9)

#### **RECOMMENDATION:**

It is recommended that the City Council:

- 1. Adopt the attached Appropriation Ordinance increasing estimated receipts and appropriations in the Water and Sewer Capital Projects Fund in the amount of \$477,884.00, transferred from available funds within the Water & Sewer Fund; and
- 2. Authorize execution of an Engineering Agreement with CP&Y, Inc., in the amount of \$277,159.00 for Sanitary Sewer Rehabilitation, Contract 102 project (City Project No. C02725).

### **DISCUSSION:**

This Mayor and Council Communication is to authorize the preparation of plans and specifications for sanitary sewer and water main replacements on the following streets, alleys and easements located in the Bluebonnet Hills, Westcliff West, Westcliff, Colonial Hills and Como neighborhood areas:

In addition to the contract amount, \$200,725.00 (Sewer: \$177,725.00; Water: \$23,000.00) is required for project management, real property acquisition, utility coordination and material testing.

This project will have no impact on the Water Department's operating budget when completed. Design is expected to start in May 2020 and be completed by September 2021. The project is part of the Water Department's Sanitary Sewer Overflow Initiative Program.
