Authorize the Execution of an Engineering Agreement with Criado & Associates, Inc., in the Amount of \$374,484.00, for the Sanitary Sewer Rehabilitation Contract 103 Project in the Riverside and Riverside Alliance Neighborhood Areas, and Adopt Appropriation Ordinance (COUNCIL DISTRICT 8)

RECOMMENDATION:

It is recommended that the City Council:

- 1. Authorize the execution of an Engineering Agreement with Criado & Associates, Inc., in the amount of \$374,484.00 for the Sanitary Sewer Rehabilitation Contract 103 project (City Project No. C02723); and
- 2. Adopt the attached Appropriation Ordinance increasing receipts and appropriations in the Water & Sewer Capital Projects (W&S Capital Projects) Fund in the amount of \$606,457.00, transferred from available funds within the Water & Sewer Fund.

DISCUSSION:

This Mayor and Council Communication is to authorize the preparation of plans and specifications for sanitary sewer and water main replacements on the following streets, alleys and easements located in the Riverside and Riverside Alliance neighborhood areas:

This project will have no impact on the Water Department's operating budget when completed. Design is expected to start in July 2020 and be completed by September 2021. The project is part of the Water Department's Sanitary Sewer Overflow Initiative Program.
