A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS, CANCELLING THE DECEMBER 8, 2020, WORK SESSION AND CITY COUNCIL MEETING, SETTING THE REGULARLY SCHEDULED CITY COUNCIL WORK SESSIONS AND CITY COUNCIL MEETINGS FOR THE MONTHS OF JANUARY 2021 THROUGH DECEMBER 2021 AND AMENDING THE CITY COUNCIL RULES OF PROCEDURE AS IT RELATES TO SETTING THE DATES AND TIMES OF MEETINGS

WHEREAS, in accordance with Sections 3.2 and 3.3 of the current City Council Rules of Procedure, unless otherwise officially changed by the City Council, the Council meets on Tuesday of each week at 3:00 p.m. for the City Council Work Session and at 7:00 p.m. for the City Council Meeting; and that for the third meeting of each month, if not otherwise cancelled or changed by official action, the City Council Work Session shall begin at 8:30 a.m. and a City Council Meeting shall begin at 10:00 a.m.; and


WHEREAS, it is proposed that the Council Rules of Procedure be amended to set the date and time of the City Council Work Session and Council Meetings by resolution rather than list specific dates and times in the Rules; and
