During the six month time period from January 1, 2020 through June 30, 2020, the impact fees collected totaled \$15,391,514.00 and were received as follows:

Retail Water Impact Fees Collected	\$7,991,012.00
Wholesale Water Impact Fees Collected	\$2,400,847.00
Retail Wastewater Impact Fees Collected	\$4,045,267.00
Wholesale Wastewater Impact Fees Collected	\$954,388.00

The CAC does not recommend any changes to the Land Use Assumptions or Capital Improvement Program at this time.
