AN ORDINANCE INCREASING RECEIPTS AND APPROPRIATIONS IN THE BOTANIC GARDENS, SYCAMORE, FIRE STATION AND THOMAS PLACE COMMUNITY CENTERS PROJECTS IN THE SPECIAL PURPOSE FUND BY A TOTAL OF \$72,953.42, TO BALANCE PROJECTS AND FACILITATE CLOSURE, AND INCREASING RECEIPTS IN OTHER PARK PROJECTS IN THE FUND BY A TOTAL OF \$253,541.60 TO BRING REVENUES INTO BALANCE WITH PREVIOUSLY APPROPRIATED AND EXPENDED AMOUNTS, WITH ALL MONIES COMING FROM AVAILABLE PARK REVENUES IN THE SPECIAL PURPOSE FUND; PROVIDING FOR A SEVERABILITY CLAUSE; MAKING THIS ORDINANCE CUMULATIVE OF PRIOR ORDINANCES; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS:

SECTION 1.

That in addition to those amounts allocated to the various City departments for Fiscal Year 2020-2021 in the Budget of the City Manager, there shall also be, in the Special Purpose Fund from available Park and Recreation Department revenues in the Fund, increased receipts and appropriations in the Botanic Gardens, Sycamore, Fire Station and Thomas Place Community Centers projects totaling \$72,953.42, to bring projects into balance, and increased receipts in other identified projects totaling \$253,541.60, to bring revenues into balance with previously appropriated and expended amounts, with such amounts detailed as follows:.

SECTION 2.

That should any portion, section or part of a section of this ordinance be declared invalid, inoperative or void for any reason by a court of competent jurisdiction, such decision, opinion or judgment shall in no way impair the remaining portions, sections, or parts of sections of this ordinance, which said remaining provisions shall be and remain in full force and effect.

SECTION 3.

That this ordinance shall be cumulative of Ordinance 24446-09-2020 and all other ordinances and appropriations amending the same except in those instances where the provisions of this ordinance are in direct conflict with such other ordinances and appropriations, in which instance said conflicting provisions of said prior ordinances and appropriations are hereby expressly repealed.

SECTION 4.

This ordinance shall take effect upon adoption.
