AN ORDINANCE INCREASING RECEIPTS AND APPROPRIATIONS IN THE CAPITAL FUNDS FOR TRANSPORTATION IMPACT FEES BY A TOTAL OF \$18,500,000.00 FOR IDENTIFIED PROJECTS FROM AVAILABLE FUNDS WITHIN SPECIFIED SERVICE AREAS; PROVIDING FOR A SEVERABILITY CLAUSE; MAKING THIS ORDINANCE CUMULATIVE OF PRIOR ORDINANCES; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS:

## SECTION 1.

That in addition to those amounts allocated to the various City departments for Fiscal Year 2020-2021 in the Budget of the City Manager, there shall also be increased receipts and appropriations in the capital funds for Transportation Impact Fees by a total of \$18,500,000.00 for identified projects from available funds within specified service areas listed below:

## SECTION 3.

That this ordinance shall be cumulative of Ordinance 24446-09-2020 and all other ordinances and appropriations amending the same except in those instances where the provisions of this ordinance are in direct conflict with such other ordinances and appropriations, in which instance said conflicting provisions of said prior ordinances and appropriations are hereby expressly repealed.

This ordinance shall take effect upon adoption.
