(CD 3) Authorize Execution of an Engineering Agreement with James DeOtte Engineering, Inc., in the Amount of \$380,276.00 for the Water and Sanitary Sewer Replacement Contract 2020, WSM-K and Adopt Attached Appropriation Ordinance

## **RECOMMENDATION:**

It is recommended that the City Council:

- 1. Authorize execution of an engineering agreement with James DeOtte Engineering, Inc., in the amount of \$380,276.00 for Water and Sanitary Sewer Replacement Contract 2020, WSM-K project; and
- Adopt the attached appropriation ordinance increasing estimated receipts and appropriations in the Water and Sewer Capital Projects Fund in the amount of \$577,950.00, transferred from available funds within the Water and Sewer Fund, for the purpose of funding Water and Sanitary Sewer Replacements Contract 2020, WSM-K (City Project No. 103421).

## **DISCUSSION:**

This Mayor and Council Communication (M&C) is to authorize execution of an engineering agreement with James DeOtte Engineering, Inc., in the amount of \$380,276.00 for Water and Sanitary Sewer Replacement Contract 2020, WSM-K project for the preparation of plans and specifications for sanitary sewer and water main replacements on the following streets, alleys and easements:

In addition to the contract amount, \$197,674.00 (Water: \$155,254.00; Sewer: \$42,420.00) is required for project management, real property

acquisition, utility coordination, and material testing. This project will have no impact on the Water Department's operating budget when completed. The sewer component of the project is part of the Water Department's Sanitary Sewer Overflow Initiative Program. Due to insufficient funds remaining in the Water Pay-As-You Go allocation for Fiscal Year (FY) 2021, Sewer funding is being used to fund the Water construction cost required in this M&C.
