THENCE South 00 degrees 33 minutes 34 seconds East, along the common line of said called 29.54 acre tract of land and said 58.449 acre tract of land, a distance of 16.68 feet to a 5/8 inch iron rod with a yellow plastic cap stamped, "ARS ENGINEERS" set for the most easterly corner of the herein described tract of land, from which a found 3-1/2 inch TxDOT brass disk, CM, bears: South 00 degrees 33 minutes 34 seconds East, a distance of 358.27 feet;

THENCE South 63 degrees 30 minutes 33 seconds West, departing said common line and being over and across said called 29.54 acre tract of land, a distance of 808.60 feet to a 5/8 inch iron rod with a yellow plastic cap stamped, "ARS ENGINEERS" set on the common line of said called 29.54 acre tract of land and a called 24.36 acre tract of land, as conveyed to the City of Dallas, Texas, as recorded in Volume 5037, Page 255, D.R.T.C.T. and being the most southerly corner of the herein described tract of land;

THENCE North 01 degrees 14 minutes 24 seconds West, along the common line of said called 29.54 acre tract of land and said called 24.36 acre tract of land, a distance of 16.72 feet to a 5/8 inch iron rod with a yellow plastic cap stamped, "ARS ENGINEERS" set for the northwest corner of said called 29.54 acre tract of land, same being the northeast corner of said called 24.36 acre tract of land and being on the existing Right-Of-Way line of said DART tract of land and also being the most westerly corner of the herein described tract of land;

THENCE North 63 degrees 30 minutes 33 Seconds East, along the common line of said called 29.54 acre tract of land and said DART tract of land, a distance of 808.50 feet to the **POINT OF BEGINNING** and containing 12,128 Square Feet or 0.2784 Acres of land.




